### ***BUSINESS MEMBERSHIPS***

A Business Membership in The Sporting Club at Providence Hill Farm allows a Business to name a Primary Member, and allows unlimited Additional Business Memberships. Additional Business Members enjoy the same privileges of membership as Individual Members. Like all Individual Memberships, privileges are extended for up to three named immediate family members of the Primary Business Member and each Additional Business Member. The business retains the rights to all memberships, and can transfer them as necessary. For example, if an employee is assigned a membership and is transferred out of state, the business can transfer that membership to a new employee by making application and payment of a nominal transfer fee.

- All Business Memberships (excluding Junior Business Memberships) include fishing.
- The Annual Fee for the Primary Member is \$5,250.
- The Annual Fee for Additional Business Memberships has been lowered to \$2,750 for each Additional Business Member. The larger the group joining the Club, the lower the average cost.
- The Business or the individual may pay for the annual membership fees and monthly expenses of its members.

### **JUNIOR MEMBERSHIPS NOW AVAILABLE FOR OUR BUSINESS MEMBERS**

A Business Member may now have unlimited Junior Business Members. A Junior Business Member is a member who is under the age of 35. A Junior Business Member has all of the advantages of Additional Business Members (excluding fishing) except that the annual Membership Fee has been lowered to \$1,500 per annual membership period. In addition, a Junior Business Member may pay the Membership Fee in four (4) quarterly installments. Once a Junior Business Member reaches 35, the Member will be treated as a regular Business Member at the time of the next renewal. All Junior Business Members are for an annual membership period and quarterly Membership Fees must be paid by credit card on file in advance for each quarterly period.

**JUNIOR MEMBERSHIPS**

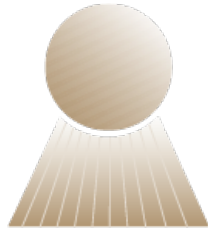

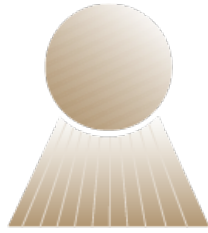

1. I wish to engage and/or participate in outdoor activities, including, but not limited to, shooting sports, archery sports, hunting, fishing, boating, horseback riding, and/or ATV and golf cart riding (collectively the "**Activities**") on property owned, leased or licensed by WCT Providence Hill Holding, LLC dba Providence Hill Farm (collectively, "**Providence**").

2. I understand and accept that my engaging or participating in any or all of the Activities exposes me and others to many risks and dangers. Some of the risks which may be present or occur include, but are not limited to:

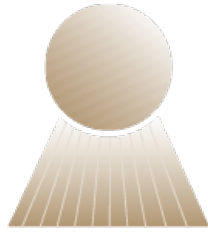
- the hazards of hunting, shooting and archery sports in general, including but not limited to malfunctions of weapons or ammunition that can result in explosions and misfiring causing traumatic physical damage to the face, head, chest, or neck;
- the hazards of using tree stands or hunting blinds;
- the hazards of self-inflicted wounds by firearms and/or bows;
- the hazards of misuse of firearms and/or bows by me and/or others, including injury or death resulting from firearm and/or discharge;
- physical pain and bruising of the arm, face, cheek, chest, or shoulder area caused by firearm and/or bow recoil;
- hearing damage resulting from firearm noise;
- eye damage resulting from firearm and/or bow use;
- the hazards resulting from the exposure to lead and other materials used in hunting and shooting sports;
- the hazards of being exposed to the forces of nature including snow, ice, rain, lightning, wind, sun, and others not named;
- the hazards of traveling in a boat or vehicle or on an ATV or golf carts whether driven by me or not;
- the hazards of participating in fishing and boating activities;
- the hazards of participating in any and all types of outdoor activities;
- the hazards of harming others by my use of firearms and/or bows, and/or my participation in any of the Activities; and
- the hazards of any participant in the Activities failing to abide by the rules and policies of Providence related to the Activities and to otherwise exercise reasonable prudence and care.

3. I understand and accept the risk that my participation in the Activities expose me to and expose others to, including but are not limited to, the following consequences: death, serious neck, spinal or other bodily injuries which may result in complete or partial paralysis, brain damage, serious injury to my musculoskeletal system and serious injury to other aspects of my general health and wellbeing, as well as to the general health and wellbeing of others that my participation in any or all of the Activities injure.
